The Saskatchewan Trucking Association recognizes the people in our industry that make driving their occupation. From the icy road conditions in the winter, to the city and highway driving all year round, many drivers are fortunate to not have any accidents.

The rules of the program are as follows:

- Applicants must have driven a commercial vehicle not less than 50,000 km on public roadways and/or have worked no less than seven (7) months, of city driving during the calendar year without being in a preventable accident.
- You are not eligible if your licence has been revoked or suspended for any reason.
- Where an applicant has been involved in an accident which they feel was not preventable, a committee will determine eligibility based upon the information provided in the Accident Declaration section of the application form. The committee's decision will be final.
